### Pacengo I and II at Lake Garda

## **General information**

### Bookings:

For all vacation properties, the normal booking is always made from Friday to Friday.

### Cancellation:

In case of cancellation more than 30 days before the start of the trip, 30% of the rental fees will be retained. In case of withdrawal from the booking within one month before the start of the trip, the loss of rent must be paid in the amount of the rental fee. The loss of rental fee is not applicable if the member is not responsible for the cancellation or if a substitute tenant can be found.

### For the registration of the vacation properties applies:

Deadline for registration for the Christmas vacations, Carnival vacations and the Easter vacations is always July 15.

Deadline for registration for the Whitsun and summer vacations is January 15.

### Energy Surcharge:

A flat fee is charged to adjust energy prices. This is variable and depends on the current market situation.

### Pets:

Bringing pets is subject to conditions that must be signed by the owner of the animal. The final cleaning fee will be increased by 10,00 €.

### Smoking:

Smoking is not permitted in any of IPP-Sozialwerk's facilities.

### House rules:

The house rules in the respective vacation apartments/houses must be observed.
